The Cincinnati Bell Telephone (CBT) Metaswitch 1 EVDLOHEVPS0 located in Evendale, Ohio 45241 will be retired and removed from the CBT network. Traffic served by this switch will be migrated to the CBT Metaswitch 2 EVDLOHEVPS2 for DS0 Trunks and to the EVDLOHEVPS7 for T1 and T3 Trunks, both located in Evendale, Ohio 45241.

## Description of type of changes planned:

The Cincinnati Bell Telephone (CBT) Metaswitch 1 EVDLOHEVPS0 located at 10000 Reading Rd, Ohio 45241 will be retired and removed from the CBT network after all traffic served by this switch is migrated to the CBT Metaswitch 2 EVDLOHEVPS2 for DS0 Trunks and to the EVDLOHEVPS7 for T1 and T3 Trunks, both located at 1000 Reading Rd, Evendale, Ohio 45241. All traffic to be migrated to the CBT Metaswitch 2 includes, but is not limited to, InterLATA (ACCESS/FG-C-D/CLEC IXC) wireless and paging traffic.

## Description of Reasonably Foreseeable Impact of the Planned Changes:

All carriers, including competitive local exchange carriers (CLECs), Interexchange carriers (IXCs, IECs), wireless carriers, and paging carriers, will need to provision new trunk groups to support direct end office trunking to the Evendale, Ohio Metaswitch 2 or have existing trunk

groups to that switch augmented. Local Exchange Routing Guide (LERG) change effective dates will be posted prior to decommissioning of the Evendale Ohio Metaswitch 1 (**on or after January 12, 2024**). This will serve to guide interconnect re-routes of traffic for the NPA codes currently served by the Evendale Ohio Metaswitch 1 to reflect the Evendale Metaswitch 2 as the new home switch.
