Lucent 5E ORM switch decommissioning in the Fairfield, Ohio central office (FRFDOHFFDS0) and elimination of the Fairfield, Ohio central office.				
Description of ty	Description of type of changes planned:			
Cincinnati Bell Telephone ("CBT") will be decommissioning its Lucent 5E ORM in the Fairfield wire center, which is a remote switch off of the North Greenhills host switch (GRHLOHNGDS0), after it completes the upgrade of the copper/metallic cable infrastructure in the FRFDOHFFDS0 wire center to fiber optic cabling system and remote Digital Loop Carrier architectures. The remote switch will be retired and removed from the CBT network and all traffic previously served by this switch will be migrated to the CBT soft-switch that resides in Evendale, Ohio (CLLI: EVDLOHEVPS0 with a point code of: 224-004-012). In addition, once the switch is decommissioned, the central office building will be removed from service.				
Description of Reasonably Foreseeable Impact of the Planned Changes:				
Direct end office trunking to the Fairfield, Ohio switch will no longer be available. IXCs or CLECs with end-office trunking to the Fairfield, Ohio central office will need to				

ensure they have proper capacity and connectivity to the Evendale soft-switch (EVDLOHEVPS0) or the CBT Access Tandem to reach these customers after this work is complete. Affected carriers must submit requests for facilities and collocation changes no later than December 1, 2014 in order to provide sufficient time for implementation.
